

Hoboken Grand Opening Giveaway Terms & Conditions

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

OVERVIEW: The Hoboken Giveaway (the “Promotion”) is a “Quikly” campaign, which involves using a mobile device or computer to (a) sign up to participate in the campaign, and then (b) respond by text or email when a notification is published that the campaign is going “live.” The more quickly you respond when the campaign goes live, the more value you’ll get.
