MyPanera Warm Grain Bowls Engagement Campaign Terms and Conditions

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE MAXIMUM NUMBER OF PARTICPANTS IS 250,000.

You will have the option of participating via email or text. Once you've signed up, you're in. At some point during the Promotion Period, the Administrator will push a notification message to you via email or text (depending on the preference selected at time of enrollment) announcing that the Quikly campaign is live. That is the signal to respond. You must click on the link in that notification.
